# General rental conditions

## General terms and conditions for the golf club rental of Rentenberger KG

### 1. General / Start of tenancy

These terms and conditions govern the contractual rights and obligations between the renter and Rentenberger KG (hereinafter "JGS") with regard to the rental of golf club sets. The respective lease is concluded between the renter and Rentenberger KG. Tenant can only be a fully legal natural person. The rental contract is concluded by written acceptance of a corresponding application for conclusion of a rental agreement by JGS.

The replacement of the rental object during the contract period for equivalent items is possible if necessary. It is also possible to exchange items of higher categories for a surcharge, but a refund is excluded when exchanging items for low-priced categories.

### 2. Duration

The contract is generally concluded for an indefinite period. An agreed minimum contract term (for example, 12 months) additionally includes the pro-rated month of the contract start date (for example, X days of the month in which the contract begins + 12 months). The contract can be terminated for the first time at the end of the month with which the agreed minimum contract term expires (for example, minimum contract period of 12 months and contract start on 15 July: first termination date on 31 July of the following year). Thereafter, he may be terminated at the latest on the last day of the month, subject to the notice period of 2 months. The. For the timeliness the arrival at JGS is decisive. In the event of injury or illness of the renter, which permanently prevents the pursuit of golf (at least 3 months) (proof of tenant's obligation), the renter is granted a right of termination at the respective last day of the month.

### 3. Fee

The contractually agreed rent and any other contributions are always due in advance (month, quarter, year). Unless otherwise expressly agreed, payments that are shorter than annual intervals are to be made by direct debit in favor of JGS, and the renter must ensure the appropriate authorization and the feasibility of recoveries at the respective due dates. In the case of chargebacks or insufficient account coverage, a processing fee of € 10.00 will be agreed for each case and will be due immediately. In case of objective default of payment default interest in the amount of 8% p.a. charged

The tenant has to pay a deposit of € 50.00 for the US Kids Ultralight Series, the US Kids Tour Series € 100.00 or € 150.00 for Cobra upon conclusion of the rental agreement. The deposit must be refunded at the end of the tenancy with proper provision and settlement of all outstanding rental fees or other claims of JGS to the tenant within 14 days on an account to be disclosed by this.

### 4. Obligations of the renter

The renter bears full responsibility for the rental property.

The renter may use the rented items only in the usual way in accordance with sporting practice. He may not use it for any purpose other than the intended use.

The lessee must immediately inform JGS in case of changed contact details.

At the end of the rental contract, the unsolicited return of the rental object must be made at the latest on the last day of the lease. Unreturned or damaged rental objects will be charged to the renter at the replacement price or at the recovery price. The lessee is obliged to inform JGS immediately of any damage to a leased object or its loss.

All rental items are insured against breakage and normal wear. In case of theft or grossly negligent damage is a deductible

in the amount of € 34 per putter / iron, € 49 per hybrid / wood and € 49 for the bag of the Ultra Light Series,

€ 44 per putter / iron, € 59 each hybrid / wood and € 89 for the driver and € 69 for the bag of the Euro Tour Series and

€ 59 per putter / iron, € 79 per hybrid / wood and € 99 for the driver and € 79 for the bag of the Cobra series.

#### 5. Liability

JGS is only liable for damages resulting from breaches of contract in case of grossly negligent and intentional behavior and the liability is limited in amount with an annual rent.

#### 6. Datenschutz und Datenverwendung

The data provided by the tenant are collected, stored and used by JGS as far as this is necessary for the processing of the contract, for the execution of the customer service as well as for the off-setting.

JGS may transmit electronic messages (in particular e-mail, SMS) to the renter for the purpose of providing information about JGS offers. JGS will transmit messages only if the renter has notified JGS of the relevant contact details in the context of the rental agreement. The renter may object to the transmission of such messages at any time

#### 7. Law / Jurisdiction

Austrian law - excluding the reference standards - as agreed,

Jurisdiction is exclusively the relevant court at the landlord's domicile.
